2022 Grundy County Fair - - - Camping Rules and Regulations

Attention Registered Fair Livestock Exhibitor Campers ---

No camper or trailer located south of the barn road, around any livestock barn area, or near the horse arena will be allowed to connect to any fairgrounds electrical power system.

You will be allowed to bring a small, quiet, portable generator to power your camper or trailer.

All generators must be of quiet type not to exceed 60db sound volume at 20ft.

All generators muffler must be affixed with a spark arrestor.

All generators must be a minimum of 20ft from any barn, tree, other structure, or combustible material.

All fuel must be stored away from barns, campers, or any combustible material.

Please be respectful of your neighbor when operating your generator.

The Livestock Exhibitor Camping Fee (No Electrical Power) will be \$10 per day or \$30 for the duration of the fair.

The Grundy County Fair is sorry for any inconvenience this may cause you, but the Fair is extremely limited on available electrical power to operate everyone's campers and air conditioners.

- 1) All campers and trailers used for living quarters will be charged a daily fee for parking.
- 2) Camping units include: Motor Homes, Trailers with Living Quarters, Pickups with Toppers and Others as Approved by Fair. Sleeping in truck cab or car will not be allowed. Camping permits will be issued to units only as determined by the Grundy County Fair.
- 3) Space is very limited. Parking of campers as directed in designated areas only. Ask at Secretary's Office or be prepared to move. No permits will be issued after available space is filled.
- 4) Camping permits will be limited to one per family.
- 5) CAMPING PERMITS MUST BE PROMINENTLY DISPLAYED
- 6) Camping location will be assigned by the Grundy County Fair.
- 7) **ABSOLUTELY NO CAMPING WILL BE ALLOWED WITHOUT ADULT SUPERVISION**. The determination of an adult rests solely with the Grundy County Fair.
- 8) Each camper is permitted one vehicle at campsite with appropriate gate pass, IF SPACE ALLOWS. Vehicles not off the roads, blocking others, or parked in a fire lane will need to be moved or they will be towed at the Fair discretion. All vehicle must display a gate pass. Vehicles without appropriate gate pass will be towed.
- 9) Electrical Hookup Limited electric hookups are available. Contact the Fair Office. No electrical hookups are allowed in any livestock barn for the purpose of camping. The Fair does not guarantee the availability or quality of electrical power.
- 10) Holding Tanks Gray water and sanitation tanks must be closed at all times. No liquid waste allowed to be dumped on ground surface. Anyone dumping on the ground will be immediately removed from the fairgrounds and proper authorities notified.
- 11) Dumping Station is available. Contact the Fair Office to make arrangements. Dumping station will not be available during the Fair or other events limiting access.
- 12) Camping sites are to be kept clean of trash/rubbish at all times.
- 13) No fireworks, charcoal or open fires permitted. Contained propane grills allowed, but must be 20ft from barns.
- 14) There is a 12 midnight quiet-time rule in effect in the camping area. Campsites will need to have all loud music off and keep conversations low at this time. Please respect your neighbor.
- 15) Parking in the camper area is limited to ONE vehicle per campsite. Please do not park in another camper's site. Please keep fire lanes and access areas around the buildings/barns open.
- 16) The Grundy County Fair and Law Enforcement have the authority to close and evacuate any camping area as they deem necessary.
- 17) Pets must be on a leash no longer than 8' at all times. Pet handlers must remove and properly dispose of all pet waste.
- 18) All garbage must be placed in provided receptacles.
- 19) Picnic tables are not provided.
- 20) Cutting, chopping or putting nails in trees is prohibited.
- 21) Use or possession of narcotics, illegal drugs, or use of vulgarity is prohibited.
- 22) The Grundy County Fair assumes no responsibility for damage or injuries to campers.
- 23) Non-compliance with these rules and regulations could result in removal of camper from the Grundy County Fair.
- 24) The Grundy County Fair reserves the right to refuse or expel anyone creating a problem at any time for any reason.

Fair Livestock Exhibitors (No Electric – Dry Camping)	\$10 per night or \$30 for duration of the Fair (Livestock Exhibitors Only)
Limited Electric – Inside the Fairgrounds	\$25 per night
Dry Camping – Inside the Fairgrounds or Parking Lot	\$10 per night
Full Hook Up – Inside the Fairgrounds	\$40 per night (Limited Electric, Water & Sewer)
Race Team Outside Parking Lot (Race Nights)	\$50 annual fee (must display annual camping permit)
Dumping Station Fee	\$10 per dump
